Abstract: The novel Ragtime written by Edgar Lawrence Doctorow, introduces us to the United states social and political climate of the early 20th century. Doctorow's Ragtime novel deals with three families namely, white Anglo family, black family, and an immigrant family. The narrative focuses on the study of the system and not individual work. At the beginning of the novel, we see that all three families had a segregated way of existence, but by the end of the story, the three families have become one in a uniquely American type of ethnic heterogeneity. Edgar Lawrence Doctorow or E.L. Doctorow who was an historical fiction writer, was born on January 6th, 1931 in New York City, Bronx. Doctorow was a great American novelist known for his skillful and undoubtful work in every novel written by him. Doctorow did his graduation with bachelor of art (B.A.) from Kenyon College in the year 1952. He then studies theater directing for a year at 'Columbia University' and then worked in New York City for a period as a scripter for 'Columbia Pictures'. He joined the American Library (new) aseditorial staff in the year 1959, he left the post of script reader after working for five years to become 'editor in chief at Dial Press'. Doctorow had been a professor in many universities and colleges like 'Sarah Lawrence college' from 1971 to 1978. Following year Doctorow became Glucksman professor in 'American and English Letters' at the New York University. Doctorow was known for the way he used to present his novels in the historic period. In total Doctorow had written twelve books, three short fiction volumes, and one stage drama. His first novel was 'welcome to hard times' in 1960 in a philosophical turn on the western genre, this novel was later converted into a film in the year 1967. Some other books of Doctorow are Big as life in 1966 in which he used science fiction, The book of Daniel in 1971, Julius from Ethel Rosenburg for espionage in 1953, and Ragtime in 1975.

Ragtime is a historical fiction which was found in almost every house from 1902 until 1912.Ragtime is inspired by the true events of America. The whole novel revolves around those historical events, characters and ideas of America. The novel talks about the life of three families i.e. The Anglo white family, the black family, and the immigrant family, and how at the beginning they had a segregated way of living, and by the end of the novel we see an ethical heterogeneity. The novel opens up with the introduction of white family and their way of earning their bread. The novel shows that all the three families had some or the other link

but the most special and astonishing or captivating thing about this novel of Doctorow is that he had not mentioned the name of any character of the white family neither the narrator is detected nor his relation with any family. The book in total contains 40 chapters and reading each chapter is like reading an essay. In the entire novel the reader will come across various social and legal aspects such as mortality, injustice, repression, time, change, women and femininity, foreignness, technology and modernization, difficulty of adaptation etc. Change, belonging and repression are the main themes of Doctorow's novel Ragtime.
