Abstract: Traffic and its rules are the one which we want to follow but we don't. When we do that's called stress and common sense when others do it's a mistake. 



All of us are aware of the following problems, like:

- 1) Minor children driving without license
- Cell phone driving is major one which is the reason for many accidents, this distracts the person from driving.
- 3) Over speeding, signal jump and overtaking in wrong direction, overtaking from left, driving in opposite direction or in one-way roads causes inconvenience in the traffic and main cause for the traffic jams.
- 4) Instead of taking U turn people try to cross to the other side at U turns which cause accidents and inconvenience also. Commutators usually don't prefer going far to take 'U' turn, instead they will go in opposite direction for near 'U' turn, this causes inconvenience for those on correct direction and also it leads to accidents as people on this side will be fast.
- 5) Even small kids know not to spit on the roads but many people spit on the roads and during travelling and driving which in this pandemic is a high risk, very inconvenient and awkward to other. People who walk on roads will try to avoid that area where now they will walk on roadsso this may cause accidents unnecessarily.
- 6) Many a people don't give way to Ambulance and they follow ambulance in order to reach destination quickly.
- 7) Last but not least attitude while driving, like over confidence, negligence, stubbornness etc.
- 8) Sometimes it may be due to failure of traffic police to control the traffic and do his work.

3. Results and Discussion

Around 42% people know about 80 % of traffic rules, which is good but many don't follow these rules, 27 % people are aware of 100% traffic rules & understand all traffic signals which is a good sign, but there are people who said that they don't mind driving on the wrong side. Some people believe in breaking the signals if they are in hurry. Cell phone driving is one of the main cause of accidents these days, 38 % people believe in that. Spitting on the road though do not cause any accident, its vary uncomfortable and a bad practice, though we all know still minors are given vehicles, where they cause inconvenience and violate the rules sometimes which in turn leads to accidents, not giving way to ambulance, blocking free left, overtaking, over-speeding are other problems which we do it by negligence or ignorance. Driving in wrong direction, parking in no parking places and in turnings cause huge traffic jam and accidents. This paper suggests that it is not the heavy transport vehicle drivers or the daily commuters who cause traffic problems but the rickshaw drivers are the major source of creating problems on roads. People believed that the accidents are because of the speed with which people drive on road which is beyond the acceptable limit.

According to this study many people don't have knowledge on traffic rules, though they have they don't follow the rules. Above graphs and table concludes that many students had been involved in RTAs as a result of over speeding. After this survey many came to know the road traffic rules and understood the importance following them. But there are still problems with compliance because of the negative attitudes and practice. This can only be solved with fair and compulsive enforcement of the regulation by the road traffic police. This study on professional and non-professional

4. Suggestions

- Do not horn continuously or don't use loud noise in car while driving.
- Do not park in NOPARKING or in narrow lanes. (these
 days we have very less parking space at apartments also
 where they are blocking the roads by parking in front of
 gates, instead build an apartment with adequate parking
 facility. If there is a colony where there are more
 vehicles and less parking then it can be solved by taking
 any open space and convert it into parking space for
 colony people)

5. Conclusion

The paper concludes that though many of them have traffic awareness and follow the rules properly. There are still a smaller number of people who don't follow the traffic rules and create huge problem whose ignorance and negligence causes the nuisance to people. Strictly following the traffic rules, MOCK shows and road shows about traffic awareness by students in co-ordination with traffic police and government would eliminate most of the problems. It is not only responsibility of the traffic police but also the people should take the responsibility of driving safely and following all the traffic rules mandatorily.

The following considerations are main reasons for traffic violation:

- 1) Signal jump & Wrong side driving
- Instead of using U turn only for U turns, using it to cross the roads
- 3) Over-speeding & Overtaking from left
- 4) Not giving way to ambulance and following it.
- 5) Pedestrians not crossing roads at Zebra crossing
- 6) Rash driving and intentionally not giving way to others.
- Some of the youth having fun in voluntary violation of traffic rules
- 8) Lack of awareness about traffic rules
- 9) No strict action against traffic violators
- 10) Spitting on the road.
