Strongly criticizing China, Bharat said that we have some very strong reasons to believe that something very wrong is going on in the structure created to fight against terrorism in the world.

Recently, China vetoed the proposal given in the UN by Bharat - backed US in which it proposed to declare Sajid Mir as a global terrorist. If this proposal is passed, according to the rule 1267 of the UN Security Council, this al - Qaeda terrorist would have been banned globally and he would have been deprived of legal travel, transaction, and any kind of legal assistance.

Bharat said that if we cannot ban those established terrorists globally just because our small interests are attached to them, then there is no point in fighting terrorism for us in the true sense. Perhaps we do not have the will to fight terrorism.

In September last year, China had vetoed the proposal to declare Sajid Mir as a global terrorist in the UN. Sajid Mir is one of the most wanted terrorists of Bharat and has a US \$ 5 million bounty on his head for his role in the 26/11 Mumbai terror attacks. China has imposed this ban on Pakistan for its personal business interests, many countries including Bharat have criticized this veto of China. China is actually a masked country which can make any kind of compromise

Steps taken by Bharat to prevent terrorism in the **Security Council** - <sup>1</sup>Bharat strongly supports all efforts, especially in the framework of the United Nations, which strengthen international and regional cooperation in the fight against terrorism. Success in the fight against terrorism goes hand in hand with progress in strengthening counter terrorism cooperation and information sharing at the international, regional and sub - regional levels. The Global Counter - Terrorism Strategy, agreed by UN member states in 2006 and reviewed every two years, is a unique and universally agreed strategic framework for combating terrorism.

Bharat is a party to 13 regional conventions on terrorism adopted by the United Nations. With the aim of providing a comprehensive legal framework to combat terrorism, Bharat took the initiative in 1996 to draft a Comprehensive Convention on International Terrorism (CCIT). Largely as a result of Bharat's active pursuit, a draft text of the CCIT emerged in 2007., which is agreed upon for most states. But some states still have problems on some issues, for which talks are going on to resolve. Bharat values the work done by the Ad Hoc Committee on Terrorism established by the General Assembly to negotiate the Comprehensive Convention on International Terrorism (CCIT). Bharat looks forward to an early conclusion of the CCIT. As a member of the Security Council, Bharat's Permanent Representative to the United Nations has chaired the Security Council Committee on Counter - Terrorism [CTC] in 2011, the Working Group on Threats to International Peace and Security by Terrorist Acts and the Somalia - Eritrea Sanctions Committee presided over.

Bharat also supports the counter - terrorism mechanism established by UN Security Council resolutions, including resolutions 1267 and 1988 and its successors against the Taliban, Al - Qaeda, ISIL and affiliated entities such as Lashkar - e - Taiba, Jaish - e - Mohammed related to sanctions. of Bharat Resolution 1373 (which, inter alia, established the Counter Terrorism Committee), 1540 (whichaddressed the non - proliferation of weapons of mass destruction in the context) and also supports subsequent resolutions that renewed, strengthened, or modified these three original resolutions. Bharat strongly supported the establishment of the United Nations Counter - Terrorism Office in 2017. Bharat believes that the establishment has provided a strong impetus to the work of the United Nations on countering terrorism and has strengthened the capacity of the United Nations to coordinate its work on this important issue. This would certainly lead to a better integrated counter - terrorism approach within the UN system. Effective and balanced implementation of the UN Global Counter -Terrorism Strategy requires greater international and regional cooperation. In this context, Bharat also contributes to the Counter Terrorism Trust Fund to support these efforts.

Bharatn Initiatives to Tackle Terrorism: Several steps were taken to streamline the security arrangements in the wake of the terror attack.

- Coastal security given high priority, and is with the Navy/Coast Guard/Marine Police.
- The National Investigation Agency, a specialized agency to deal with terrorist crimes, was set up and has been functioning since January 2009.
- National Intelligence Grid (NATGRID) has been constituted to create a proper database of security related information.
- Four new operation centers have been set up for the National Security Guard to ensure quick response to
- The Multi Agency Centre, which functions under the Intelligence Bureau, was further strengthened and its activities expanded.
- Navy sets up a Joint Operations Center to monitor Bharat's extended coastline.

There is a need to bring some necessary reforms to deal with terrorism which should be implemented -

- An essential aspect of combating terrorism is effectively curbing terror financing.
- Objective and evidence based proposals for listing terrorist groups, especially those groups that prevent their access to financial resources,
- The international community should rise above political differences and defeat the challenge of terrorism.
- Technological solutions are necessary to enhance and complement traditional methods of border security.

They not only enhance the surveillance and detection capabilities of border guarding forces but also improve the effectiveness of border guarding personnel against infiltration and cross - border crimes.

Bharat must move towards specialization of the military to fight cross border terrorism.

The Army should also consider alternative methods of striking terror camps across the LoC and LAC through mechanisms such as Precision Engagement Capability. A judicious mix of appropriately trained manpower and cost effective and tested technology is likely to yield better results. The war against terrorism is a low intensity struggle or localized war and it cannot be fought without full and continuous support of the society and can be easily lost if the morale and resolve of the society to fight against terrorism weakens.

It is a constant effort of Bharat to respond to global terrorism in the harshest form, for this, Bharat has been raising voice from every platform to stop the growing form of terrorism. Be it G20 or Asia summit, Bharat gives the same slogan everywhere. It is said that terrorism and talks cannot be done together, because of this, the concerned countries will have to curb the activities of terrorism, whatever may be its consequences.
