In an untouchable conference, Shahu Maharaj once said “you have found a saviour in Ambedkar, he is a twenty nine year old and he will become front line leader of the country, he will definitely break all your shackles” The statement has given in 1921, yet it is too relevant in today's scenario. Babasaheb Ambedkar's vision for social justice to promote liberty, equality and brotherhood. According to him the main reason for the untouchability is the caste system.

Dr B.R. Ambedkar's Efforts for Social Justice

Ambedkar dedicated his entire life to bring social justice and the empowerment of downtrodden communities of India. His concept of social justice was transformative and laid the foundation for the empowerment and emancipation of untouchable communities in India. Ambedkar and Untouchability

In the book the untouchables, Ambedkar raised two questions. The first one “are the Hindus the only people in the whole world who observe untouchability? The second

is if untouchability Is observed by non- Hindus also how does untouchability among Hindus compare with untouchability among non- Hindus? (Ambedkar. The untouchables Who are they and why they become untouchables?) In the same book Ambedkar raised similar questions like why do the untouchables live outside the village? calling them an outcaste. Untouchability is a sin of Indian society. According to Ambedkar the religion should treat all the humans equally. He said “I like the religion that teaches equality, liberty and fraternity “For him. Untouchability a Social Evil, and analysed it as deep- rooted social evil and the religion- based caste system is main cause for untouchability and it creates huge discrimination among the people. Hence, he demands for equality. For social justice Ambedkar believed in the complete abolition of untouchability and fought for the social, economic, and political rights of the oppressed classes. To promote education especially for untouchables he established Bahishkritha Hithakarini sabha. He aimed to provide education for the downtrodden or marginalized communities and seeking equal opportunities in socioeconomic field. Through, the journals like Mook Nayak, Bahishkrit Bharat, and Equality, Janata he wrote several articles and writings to create awareness among Dalits or untouchables of this country. Along with these efforts temple entry movement was one of the remarkable efforts in the history of India. Ambedkar realized that the Abolition of untouchability and the inclusion of the marginalized groups in public life required religious change and not merely social or economic progress.” (Shashi Tharoor, Ambedkar- A life, Aleph 2022) According to Baba saheb Ambedkar the abolition of untouchability can occur only through the religion.
