To achieve sustainable development education is essential as it create awareness among the people about the importance of sustainable development. ESD is a dynamic concept that utilizes all aspects of public awareness, education and training to create an understanding of the linkages among the issues of sustainable development.

5. Methodology

Methodology is an important part of research activity. In the present study methodology has been presented under the following heads:

- 1) **Method:** Descriptive research method was adopted in this study.
- 2)**Population:** The population of the study comprised of all the post-graduate students studying general post graduate courses in the 15 general post graduate departments of Dibrugarh University in the academic session 2012-13 and 2013-14.
- 3)**Sample:** For the present study, the researcher had selected 9 general post graduate departments of Dibrugarh University using purposive sampling technique. Then samples of 100 students were selected from the sample departments using incidental sampling technique.

6. Tools of Data Collection

- Questionnaire: For the collection of primary data one questionnaire was prepared by the investigators to study the awareness level of the post-graduate students of Dibrugarh University regarding Education for Sustainable Development and then the questionnaire were distributed among the students of sample departments and filled in forms were collected later on.
- Secondary data were collected from various books, publications, research report, internet etc.

• Analysis of Data:

Qualitative and quantitative analysis were done in present study. Percentage was used to carry out the analysis task of the data.

7. Findings of the Study

The findings of the study are mentioned below---

In the study, it was observed that regarding the concept of sustainable development 85% of students agree with the definition given by Brundtland Commission. It was also observed that 76% of students agree on the three dimensions of sustainable development. 88% of students opined that sustainable development is very important for proper development of a nation and majority of students (90%) consider education as the single weapon to achieve sustainable development.

Regarding the Decade of Education for Sustainable Development, 55% of students had given correct responses. Majority of students (81%) opined that Education for Sustainable Development (ESD) simply means Education for Environment Protection, whereas 75% of students opined that Education for Sustainable Development should

include environment protection as well as social justice and economic wellbeing.

A major part of students (66%) opined to make students able to evaluate many different perspectives of environment and development as the main goal of ESD. Whereas only 10% of students opined to get knowledge about environmental issues by studying scientific facts and 15% of students opined to make students able to develop an environment friendly behavior as the main goal of ESD.

Regarding the central subjects of ESD, majority of students (75%) choose ecological, economical, social and ethical aspects.

A small minority of students preferred natural and social science should be the central subjects of ESD. A major part of students (66%) preferred critical discussion among students and teachers as the teaching and learning method of ESD. Regarding the major thrust of ESD only 47% of students had given correct response.

Regarding the lessons and materials for ESD, the study showed that, new separate optional courses are not supported widely by students. Majority of students choose new separate compulsory courses and inclusion of sustainable development in some existing courses (56%). Regarding the best means of teaching and learning of ESD 89% of students choose-- lectures gives by specialist from various relevant areas. 34% choose story-telling, 41% choose field trip, 10% choose class discussion, 11% choose class project and 15% of students choose assigned reading as teaching and learning method of ESD.

Majority of students (87%) opined that all human being must adopt energy sewing and resource conservation life style for sustainable development. On the other hand, 69% of students opined that preservation of environmental quality and ecosystem is must for sustainable development. 79% of students opined that research and education activity towards sustainable development should be encouraged.

8. Suggestion and Conclusion

The findings of the study reveal that the Post-Graduate students of Dibrugarh University are found to be highly aware regarding ESD. But it is also seen that in some areas a small minority of students are not found to be aware. Therefore, on the basis of these findings we may suggest to organize conferences, seminars, discussions on sustainable development issues and encourage them to participate in the same. It is also suggested to encourage research and education activity towards sustainable development. As education is the most powerful instrument to make students able to aware regarding any issues, therefore, it is necessary to include all the aspects of sustainable development into formal educational settings as a new separate optional courses or a compulsory course or can be included in some existing courses.

Post-Graduate students are the architect of future society and so they should be aware about ESD to prevent the life in this planet from the serious threat of environmental pollution and to achieve global environmental sustainability.
