Emotion are biological sate associated with nervous system brought on by neurophysiological changes variously associated with thoughts, feeling, behavioral responses, and a degree of pleasure or displeasure. An exploratory study with simple random sampling technique was carried out at sri guru Nanak Dev Homeopathic Medical College, Ludhiana. Cases were followed up to six month and assessment was done once in 15 days. Objectives: To study the role of different repertories in treatment of emotion disorder, To promote good health and change of lifestyle by advise and counseling. Result: The uses of homeopathic medicinehas a beneficial effect in case of prominent feeling of love and hate. Conclusion: The findings of the above study concluded that 96% of the cases responded well to the indicated homoeopathic similimum. This study proved the rubrics of emotion love and hate play a significant role in the homeopathic prescription and homeopathic treatment.

The cognitive components are related to the devaluation of the other, the perception of them as a threat. The emotional part includes a set of feelings like anger, fear, distress, and hostility. Finally, another element related to hatred is a certain, sometimes crazy, sense that we are justified in acting against – or even eliminating – the object of our hate.

2. Materials and methodology

Study Setup: it is an Exploratory Study, with an sample size of 50 paitients.

Subject: The subject for the study has been selected from the patients attending OPD, IPD, and peripheral dispensaries of Sri Guru Nanak Dev Homoeopathic Medical College & Hospital.

Study parameters: Observations were made according to the change in the symptoms of patients.

3. Outcome of the Study

Out of 50 patents 48 patients shown positive result that mean 96% of improvement. 25 cases in age group between 21-30yrs, 5 cases in the age group below 20yrs. 10 each in patient between 31-40yrs and between the age group 41-50yrs were reported. The study also reflects that among 50 patients, the rubric related to love was seen in 25 cases and in 16 cases hate was in dominance where as in 9 cases mixed picture of love and hate was witnessed.

In the study 18 cases were from ailments due to anxiety, 15 cases due to suppressed anger, 10 cases of fear, grief and brooding, 8 cases of want to confidence and disappointment, 6 cases of weeping, affectionate, reserved, 7 cases of over sensitiveness, 5 cases of emotional affects and business cares, 3 cases each of hatred, forsaken, irritability, 2 cases of each insecurity, discords between relative, suicidal thoughts and 1 cases each of benevolence, death of relative, gourmand, resentment, mortification, reproach, jealousy, ambition deceived, and ambitious were successfully treated, using homoeopathic medicines, with the aid of various repertories.

4. Conclusion

Total 12 medicines were found useful in this study and most of the cases we found rubrics related love and most used medicine was Natrum Muraticum. And homeopathic medicine found useful.
